## Other specific restrictions:

- (2) For any individual crop the maximum total dose refers to the total dose of any product containing the same active ingredient.
- (3) Application by tractor mounted/trailed/orchard blast sprayer only.
- (4) Post application, do not allow unprotected persons to enter treated areas until the crop is completely dry & has been well ventilated.
- (5) For environmental information refer to the product label but specifically: To protect aquatic organisms respect an unsprayed buffer zone of 50m to surface water bodies from tractor mounted/trailed/orchard blast sprayers. Aim spray away from water. Growers may be eligible to reduce the buffer zone under the PRCD STRIPE Scheme.
- (6) This approval extends to professional use only.
- (7) For operator protection refer to the product label in conjunction with the specific restrictions above.
- (8) Adverse effects: Approval holders must immediately submit any new information on the potentially dangerous effects of a product or residues of an active substance contained in a product, on human or animal health, or the environment.

This approval relates to use of Curenox 50WP as a horticultural fungicide for use on the crops & situations listed above.
