Who is Growing Media Ireland?

- GMI represents the majority of horticultural peat producers in Ireland, large and small (excluding Bord na Mona)
- GMI members are committed to best environmental practice in horticultural peat harvesting and the responsible use of peat for both professional horticulture and the retail market
- GMI members only harvest horticultural peat on non-designated bogs



Irish Horticultural Peat Sector

- 5,500 hectares 0.4% of total Irish peatland
- 0.52% CO2 emissions from horticultural peat is 0.52% of projected total Irish emissions
- 6,600 direct and 11,000 indirect employees in the Irish Horticultural Sector
- € 497m employment value
- € 239m value of Exports



Legal and Planning Problems

- September 2012 Peat Harvesting "exempted development"
- April 2013 An Bord Pleanála decision, no longer "exempted development"
- April 2013 February 2018 Judicial Review Process
- March 2018 December Leave to Appeal Declined
- January 2019 Statutory Instruments amended legislation
- July 2019 Friends of the Irish Environment Injunction
- September 2019 High Court Quashed Statutory Instruments



Current Regulatory Process

- Apply to An Board Pleanála for leave
 - If granted then:
- Apply to an Bord Pleanála for Substitute Consent (18 24 months)
 - If granted then:
- Apply to Local County Council for Planning Permission (18 24 months)
 - If granted then:
- Apply to EPA for a licence (24 30 months)



Proposed GMI Solution

The solution is not complicated:

- Remove Peat Harvesting from the Planning regime (again)
- Improve the environmental licensing process to comply with the guidance from the High Court Judgement



Horticultural Peat Stocks

- Sufficient good quality peat stocks for between 12 18 months
- If no harvesting in 2021, then only imported products for 2022
 - Increased leadtimes (allow 2 3 weeks for deliveries)
 - Much greater pressure on growers to carefully plan deliveries
 - Less flexibility
 - Bulk deliveries will probably be prohibitive on cost grounds; most likely only delivery formats will be IBC Bags and Big Bales
 - Much increased cost e.g..:
 - Nursery stock delivered in Big Bales will increase by approx. €31/m³
 - Nursery stock currently delivered in Bulk will have to be delivered in Big Bales, resulting in perhaps a €37/m³ increase



Peat and the Programme for Government

- The draft Programme for Government includes the aspiration to 'Exit from Peat in the Midlands'
- In this heading the proposed coalition parties commit to 'Publish and implement a detailed all-of-Government implementation plan consistent with the recommendations of the first report of the Just Transition Commissioner.'
- Kieran Mulvey's Just Transition Progress Report suggests:

"If we are to encourage and support investment in the Midlands and other areas, then some fasttrack 'one-stop-shop' arrangement needs to be considered for planning, licensing and regulatory compliance."

 Let us hope that this issue is given the required priority to ensure that harvesting can recommence in 2021
